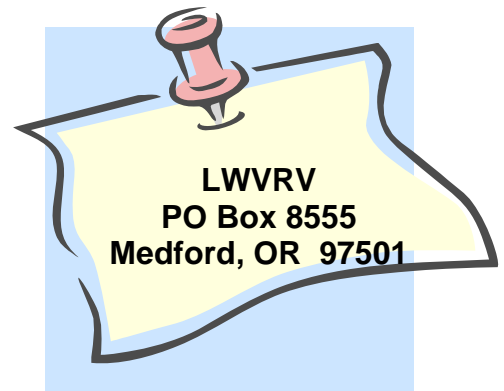

Even if you're not an expert on the computer, it's easy to download the *Voter's Voice* and print it out if you wish. You have two ways of doing this:

### 1. BY E-MAIL

Carole Levi, our talented newsletter editor, will e-mail you a copy of the *Voter's Voice*, in PDF form, to everyone requesting this method of distribution. OR

### 2. FROM OUR WEBSITE

On the World Wide Web go to [www.lwvrv.org/newsletter.htm](http://www.lwvrv.org/newsletter.htm) Book mark it into your favorites for your next time use. Click on the most current newsletter link, and print it out if you wish.

NOTE: Most of you already have the free Adobe Acrobat Reader, a program which allows you to open and download pdf text and pictures. If you don't, here's what you do:

1. ON THE WEB go to [www.adobe.com](http://www.adobe.com) and follow their directions for the free program to be downloaded to your computer. OR

2. GO TO OUR WEBSITE( see above) and look for the logo that says "Get Adobe Reader", click on that to download. August 2008: The latest version of Adobe Reader is version 9 but if you have an older computer, Windows or Macintosh, look for its system requirements, probably version 7.0.9 or 7.1.0 or 8.1.2

Help is available if you have trouble downloading, and you'll only have to do this once.

# LAND USE ISSUES IN JACKSON COUNTY

The Regional Problem Solving Project (RPS) has been challenged by Oregon Department of Land Conservation and Development and 1000 Friends of Oregon on the excess urban reserve areas proposed for development. Since DLCD will not accept some of the proposed Urban Reserve areas by Jacksonville, they may drop out of the RPS process. And if that happens, DLCD will try to preserve RPS without Jacksonville. We expect to have a decision to Jacksonville's participation in the RPS process by May.

1000 Friends has asked RPS to reduce the Urban Reserve in RPS by 1400 acres. If not, then 1000 Friends will challenge RPS in court. RPS has designated about 9000 acres in Urban Reserve areas of which 7500 acres are presently EFU lands. The RPS policy committee is now working on identifying which Urban Reserves will be dropped from the RPS plan to satisfy 1400 acres reduction. First, they must consider how much in fill is possible inside the present city limit and UGB in all cities to accommodate a population growth in 50 years. Only then can they make a decision on how much each city will need for Urban Reserves. Yet, RPS must have public hearings before final approval by LCDC in August unless the RPS process is ruled not a land use decision.

Housing prices have fallen more sharply for homes requiring long commutes to jobs and to other important facilities while in-town commutes have kept home prices from falling as much because of high gas prices.

The price on homes with long commutes such as 1-2 hours have fallen as much as 50% in the eastern states. I would think the same is probably true in Oregon.

Hopefully, next fall we will be able discuss how the state plans to reduce global warming gases and possible changes in the state's land use planning to protect Oregon's natural resources as well as farm lands. Various agencies are working together to help plan on how it will be done. Also, the Big Look Committee has been restarted to improve land use planning. Early indication seems to show they want to loosen the permitting of Development. Let's hope not.

**72%** Percentage of voting-age citizens who were registered to vote in 2004, compared with the 70 percent in 2000.

**126 million** The number of people who voted in the November 2004 election — a record high for a presidential year.

**89%** Percentage of registered voters who reported casting ballots in 2004, up from 86 percent in 2000.

**65%** Percentage of women who voted in the 2004 presidential election, compared with 62 percent of men.

**72%** Percentage of citizens 55 and older who voted in the 2004 presidential election. **20%** Percentage of voters who reported voting before Election Day 2004 — either in person or by mail.
