The **2010 United States midterm elections** will be held on Tuesday, November 2, 2010. All 435 seats in the United States House of Representatives and 37 of the 100 seats in the United States Senate will be contested in this election along with 38 state and territorial governorships, many state legislatures, four territorial legislatures and numerous state and local races.

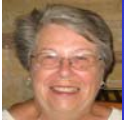
"..For much of our history, America was a predominantly agrarian society. Law makers therefore took into account that November was perhaps the most convenient month for farmers and rural workers to be able to travel to the polls. The fall harvest was over, (remember that spring was planting time and summer was taken up with working the fields and tending the crops) but in the majority of the nation the weather was still mild enough to permit travel over unimproved roads.

Why Tuesday? Since most residents of rural America had to travel a significant distance to the county seat in order to vote, Monday was not considered reasonable since many people would need to begin travel on Sunday. This would, of course, have conflicted with Church services and Sunday worship.

Why the first Tuesday after the first Monday? Lawmakers wanted to prevent election day from falling on the first of November for two reasons. First, November 1st is All Saints Day, a Holy Day of Obligation for Roman Catholics. Second, most merchants were in the habit of doing their books from the preceding month on the 1st. Apparently, Congress was worried that the economic success or failure of the previous month might prove an undue influence on the vote!"

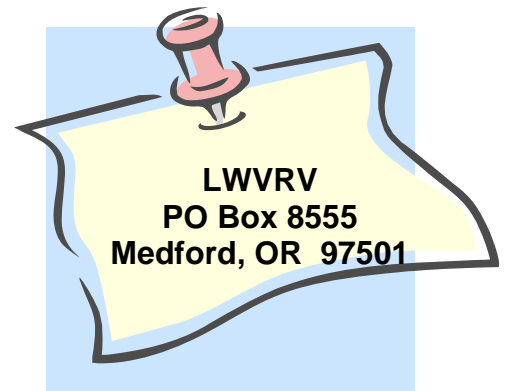

## VOTERS SERVICE

Our League had very successful Voter Service events during this election session. To say this is a group effort would be an understatement. During the time that was set up for our Voter Service events, I became sick. Many of our League members covered for me during this time and I owe them a heartfelt thanks.

In October we held a number of successful candidate forums. The first one featured our State Senator candidates and four State representative candidates. This event had a good turnout and since we had it televised it was shown many times by RCC/SOU Community Public TV. Our League has to pay for the taping but we receive lots of exposure during the election season.

We also had our League meeting covering the State ballot measures. At the Rogue Valley manor we hosted the two candidates for State representative for their district.

Talent and Phoenix both asked us to moderate the candidates for their local elections.

I would like to thank Eileen Adee, Agnes Chirgwin, Barbara Davidson, Margaret Keene, Cynthia Lora, Bill Mansfield, Shiena Polehn, Robin Stroh and Nancy Swan. Having their support during this election time make my job much easier. We are fortunate to have them in our League.

## A Salute to United Nations Peacekeepers [UNPK]

Organized in 1948, the UNPK have undertaken over 63 field missions which among other things, helped people in dozens of countries participate in free and fair elections and helped disarm over 400,000 ex-combatants in the past decade alone.

Today, 124,000 UNPK personnel are deployed with 16 distinct operations around the world directly impacting lives of hundreds of millions of people – a nine-fold increase since 1999. As of March 31, 2010, 115 countries contributed to UNPK personnel including: troops, military observers, police, civilian staff, and volunteers from over 160 countries.

Contrary to what one might conjecture, the UNPK operations cost much less than other forms of intervention and, more importantly, the cost is shared more equitably among UN Member States. The most recent 2009-10 budget for UNPK operations was about \$7.9 billion – a mere 0.5 percent of global military spending estimated at \$1.464 trillion. A US Government Accountability Office study estimated that it would cost the US twice as much as the UN to conduct a peacekeeping operation similar to the UN Stabilization Mission in Haiti. In the words of Ambassador Susan Rice, U.S. Permanent representative to the UN, “If the US was to act on its own – unilaterally – and deploy its own forces in many of these countries, for every dollar that US would spend, the UN can accomplish the Mission for 12 cents.”

UNPK work in areas where no one would want to go – this at great danger to their lives and great sacrifice to their families. Hundreds have lost their lives while on the job as peacekeepers. Readers may remember the tragic incident in Iraq where the entire UN mission building was blown up by insurgents resulting in many deaths. I believe we owe a deep debt of gratitude to UNPK on this International Day of Peace [September 21, 2010] and salute them for their sacrifices and dedication to peacekeeping.
